Now this the 10 day of October, 2010 came on for hearing the matter of establishing a Planning Commission for Lewis County, West Virginia, at which it is proposed to include all of the land lying within Lewis County, West Virginia in the planning area.

For the testimony and evidence presented and matters and things appearing before the Commission, the Commission does find that such a Planning Commission is needed for the purpose of development and planning of Lewis County.

WHEREFORE, premises considered, pursuant to the authority vested in the Commission by WV Code §8A-2-1, it is hereby ordered, adjudged and decreed that a Lewis County Planning Commission be created and that the area of planning shall include all of the lands lying within said county, and said commission shall have 7 members, subject to later revision. Said commission is hereby empowered to carry out all the purposes and objectives contained in WV Code §8A-2, and said commission shall be known as the Lewis County Planning Commission.

AMDENDED this 1st day of August 2023 to reflect the actual number of members; originally approved by Lewis County Commission on the 10th day of October 2010.

The Land Use and Sustainable Development Law Clinic at the West Virginia University College of Law ("Land Use Clinic") proposes to develop a Comprehensive Plan Update for the Lewis County Commission at a cost not to exceed \$18,840. This cost may be spread across two budget years, at the option of the County. The Comprehensive Plan will meet all statutory requirements for compliance with the West Virginia Code.

The Land Use Clinic is the leading provider of planning services in the state of West Virginia. The Land Use Clinic has worked with numerous communities to draft comprehensive plans and land use ordinances in accordance with the requirements of the West Virginia Code. In addition, the Land Use Clinic focuses on outreach and education to train local government officials to promote sustainable land use policies and practices across the state. The Clinic has extensive experience in developing county comprehensive plans. County comprehensive plans that have been developed by the Clinic include Calhoun County, Wirt County, Mercer County, McDowell County, Wyoming County, Doddridge County, and Harrison County. The Land Use Clinic also has experience in Lewis County with the development of the City of Weston's Comprehensive Plan (2014) and Zoning Ordinance (2019).

This proposal is structured to meet minimum statutory requirements and use Land Use Clinician time in an efficient way to keep costs down for the benefit of Lewis County. The proposed budget includes all planning commission meetings to be conducted in person. However, some meetings could be conducted via Zoom to minimize Clinician travel and lower the proposed budget. In addition, the timeline is contingent on homework assignments being completed by planning commission members in a timely manner and appropriate participation at meetings by ensuring quorum is achieved.

The proposal also incorporates the Town of Jane Lew into the comprehensive plan process. The mandatory elements of a comprehensive plan specific to the town would be integrated throughout the County Plan. The Town of Jan Lew must participate throughout the planning process. During the adoption phase, the Town of Jane Lew would then have to "consent" to the

County Comprehensive Plan and the plan would then officially be considered the town's plan. This integrated process will keep the cost low compared to a traditional stand-alone municipal comprehensive plan. If the county and/or town desires a more detailed approach, then additional time and cost may be warranted beyond the base cost listed above.

Qualifications of the Land Use Clinic

The vision of the Land Use Clinic is to improve the quality of life in West Virginia through land use planning, land conservation, and education. Over the last ten years, the Land Use Clinic has supported over 50 communities, including 11 counties, with the development of 49 comprehensive plans and 22 zoning ordinances. For example, the Land Use Clinic has worked or is currently working with the following local governments:

- City of Huntington (Comprehensive Plan and Zoning Ordinance)

Project Team

Christy Burnside DeMuth, AICP, Land Use Planner would lead the effort with support from Jared Anderson, AICP, Land Use Attorney, and Whitney Morgan, Land Use Clinician.

Christy DeMuth is the Land Use Planner at the Land Use and Sustainable Development Law Clinic. Christy received her Bachelor of Science in Environmental Resources Management from Penn State in 2003 and a Master of Science in Geography from the Indiana University of Pennsylvania in 2005. She began her career in government, first working at Peters Township, a suburb of Pittsburgh, in the Planning Department and then in the Department of Economic Development in Allegheny County, the second largest county in Pennsylvania. In 2006, DeMuth began planning work in the private sector in Pittsburgh, where she managed several planning projects, such as comprehensive plans, zoning ordinances, subdivision and land development ordinances, planning studies, economic development plans and corridor studies. As a project manager, Christy was responsible for coordinating public participation efforts for all her clients, which included facilitating numerous public meetings, focus group meetings, committee meetings,

and educational workshops. She is also well versed in the use of Geographic Information Systems (GIS). In her past ten years with the Land Use and Sustainable Development Law Clinic, Christy has developed numerous comprehensive plans and zoning ordinances for communities throughout West Virginia. Christy has also been a member of her township planning commission since 2015.

Jared Anderson received a B.A. in Geography with a minor in Economics from West Virginia University where he was a member of the WVU Men's Tennis Team. After graduating, he worked as a GIS specialist for an engineering firm in Virginia. Later, he moved out west to attend the University of Hawaii, where he obtained a Master of Urban and Regional Planning. In 2007, he moved back to Virginia to become the Planning Director for the Town of Chincoteague. While there, he was responsible for all the day-to-day planning activities, including a complete revision of the town's comprehensive plan. Detailed Work Plan

Facilitation of Meetings with Local Leadership

The Land Use Clinic will work with the County Commission, the Lewis County Planning Commission, county attorney, staff, the Town of Jane Lew and other local leaders to identify

appropriate public input procedures, identify key stakeholders, and thoroughly review all existing plans. This process will give the team an idea of how to move forward without replicating any steps. The Land Use Clinic will work with the Planning Commission throughout the comprehensive planning process to collect background data, identify a vision, and create an action plan that complies with the goals and objectives of the county and its residents.

Collection of Stakeholder Interviews

The Comprehensive Plan Update will be tailored to Lewis County and will include interviews with local stakeholders, as needed, to ensure a full cross-section of the community has had an opportunity to participate.

Public Input

Public input will be vital to ensure the plan's success and initiate change in the county. The Clinic will review input from the previous Comprehensive Plan and other planning studies. The Clinic and local officials will determine the best way to solicit additional information from citizens and members of the public. The Land Use Clinic will facilitate 5 open houses (which includes one in the Town of Jane Lew) to ensure that there is opportunity for public input prior to plan adoption. An online survey will also be utilized to gather information from those who typically do not or who cannot attend public meetings. These surveys have often yielded great results. For example, during the Hinton Comprehensive Plan process the planning commission developed an online survey and received 402 responses. For more information on our public input process, see the detailed timeline below.

The Land Use Clinic will visit Lewis County High School to conduct a youth focus group to identify the issues and concerns of the youth. Younger people are an important demographic of the community that often do not participate in planning efforts. For example, the Clinic gained important insight after meeting with students in 2013 at Elkins High School, as part of the comprehensive plan process.

Visioning and Data Collection

The Land Use Clinic will gather and synthesize information from the latest Census and from other sources to identify statistical and historical conditions and trends within the county, including, but not limited to: employment, including workforce participation; income; infrastructure; housing; education, health, and social services; and social, cultural, and recreational opportunities.

Needs Assessment and Action Plan

Based on the public input received and data obtained during the visioning and data collection process, the Land Use Clinic will facilitate community-driven identification of issues of common concern. These issues will then be developed into specific goals, objectives, and action steps

(together with potential sources of funding). The end result will be a plan with clear steps that the county needs to take in order to achieve its desired goals and objectives.

Compliance with Chapter 8A of the West Virginia Code

Certified AICP planners and licensed attorneys will develop the needs assessment, help facilitate meetings, and draft sections of the comprehensive plan in compliance with Chapter 8A of the West Virginia Code. The entire comprehensive plan draft will be thoroughly analyzed to ensure that it not only meets the needs of Lewis County but meets required objectives and components of Chapter 8A.

Optional Services

The optional services listed below would be an additional cost on top of the base price of \$18,840.

The Land Use Clinic may add optional services and chapters, for an additional charge, based on the particular needs of Lewis County.

Additional Open Houses

A total of five open houses are included in the base price. Additional open houses can also be held if the Planning Commission believes more input is needed throughout the planning process.

Visitor Survey

The Land Use Clinic can prepare an online visitor survey to solicit input from county visitors regarding their issues and concerns when visiting the county.

Youth Survey

The Land Use Clinic can prepare an online youth survey to identify issues and concerns of the youth.

Planning Commissioner Training

The Land Use Clinic can provide training sessions and be available for follow-up questions. These training sessions will focus on the powers and duties of the planning commission, the importance of the Open Meetings Acts, and how to properly conduct a meeting. Other topics may be substituted if there is a need that is mutually agreed upon by the Clinic and the County Commission.

Timeline

Fall/Winter 2023

- Conduct SWOT analysis with Planning Commission and stakeholders
- Develop procedures for public input
- Review existing plans
- Work with the Planning Commission to develop a list of stakeholders
- Tour the County with partners to identify assets as well as challenges

Winter/Spring 2024

 - o Realtors
 - o Parks & Recreation

- Lewis County Economic

- Solicit public input through established procedures. Steps would likely include:
 - o Two community surveys (Lewis County and Town of Jane Lew)
 - o Open houses to continue to identify issues and concerns via SWOT analysis
 - o Stakeholder Surveys
 - Youth focus group and/or optional youth survey to identify student's needs, concerns, and recommendations
- Review demographic and economic data

Summer 2024

- Develop existing and future land use maps (any other necessary mapping for the comprehensive plan)
- Develop vision statement and goals
- Discuss the Needs Assessment with the Planning Commission

Fall and Winter 2024/Winter 2025

- Finalize existing and future land use maps
- Develop action items
- Optional open house to prioritize action items
- Land Use Clinic will submit draft of plan to Planning Commission for comment
- Finalize plan, begin adoption process (adoption process typically takes 3-4 months due to notice and comment periods and multiple public hearings).

I think I understood from Gary that we really do not need a new ordinance, we can use our existing one and he has a way to get around folks signing their name when submitting complaints. I believe he was saying we would be fine with what we already have from 2010 for Safe Sites as far as our ordinance and following the old code goes.

However, I believe Commission wants to adopt/implement the IMPC. Even with that, Gary's advice was that we still DO NOT need a new ordinance, etc. I believe he said we would use the language of us adopting the IMPC as a reference??? I want to make sure we get this on the next agenda correctly. I am looking for input and of course want to make sure we are in line with code and ethics. Please review what I've drafted below.

Safe Sites and Structures: The Lewis County Commission will consider the reorganization of the Safe Sites and Structures Committee, and Ordinance, that was approved in 2010. As part of the reorganization, the Commission will consider adopting the International Property Maintenance Code pursuant to West Virginia Code 7-1-3n as a reference to be used by the Safe Sites Committee, for the purposes of safeguarding life and property in and throughout the unincorporated parts of Lewis County, West Virginia.
