Dear Mr. Breen,

This letter is in response to our recent conversation wherein you requested that I review the Leases and Development/Operations agreements (hereinafter "documents") for Stonewall Jackson Lake State Park (hereinafter "Park"), and provide my opinion of whether any taxable interests are present within the "documents" for property taxation purposes in the State of West Virginia. In this regard, I offer the following for your information.

Review of the "documents" indicates that all interests in land at the "Park" rests with the United States Government, Department of the Army. Given that the land in question is owned by the United States Government, your attention is directed to provisions of West Virginia Code §11-3-9 (a) (1) which provides in pertinent part: "(a) All property, real and personal, described in this section, and to the extent limited by this section, is exempt from taxation: (1) Property belonging to the United States, other than property permitted by the United States to be taxed under state law ... ". My review of the "documents" does not disclose any instance where the United States ownership interests in the land are permitted by the United States to be taxed for property taxation purposes. Therefore, under provisions of West Virginia Code §11-3-9 (a) (1) the land owned by the United States located at the "Park" is exempt from property taxation.

Review of the "documents" further discloses that the State of West Virginia retains title to all improvements constructed in the "Park" as a result of lease agreements between the Department of the Army and the West Virginia Department of Commerce. Given that such improvements are owned by the State of West Virginia, your attention is directed to provisions of West Virginia Code §11-3-9 (a) (2) which provides in pertinent part: "(a) all property, real and personal, described in this section, and to the extent limited by this section, is exempt from taxation: ... (2) Property belonging exclusively to the state; ...". Therefore, under provisions of

West Virginia Code §11-3-9 (a) (2) the improvements to land made in conformity with the "documents" and owned by the State of West Virginia are exempt from property taxation.


In addition, I reviewed the documents to see if any chattels real or chattels personal interests were present as a result of lease agreements. My review did not disclose any lease agreements creating any such interests. Rather the documents contain certain development and operations agreements but do not contain any lease agreements that might be considered to be taxable under provisions of West Virginia Code §§11-3-7a, 11-5-3, and §110-CSR-1P-3.3.

Thus it appears that the land owned by the United States and improvements owned by the State of West Virginia (leasehold improvements) located in the "Park" are exempt from property taxation. In addition, there does not appear to be any taxable chattels real or chattels personal interests in said property arising from leasing of such property.

However, if there is tangible personal property (office equipment, furniture and fixtures, inventory, or any other business personal property) located on the property, and owned by entities other than the United States or the State of West Virginia, such property may be reportable and taxable under provisions of West Virginia Code §11-5-1 et. seq.

I trust that the above is sufficiently responsive to your request. As always, should you have additional questions or should you care to discuss these matters in more detail, please let me know.
